3. The said Safdar Ali (hereinafter referred to as the Declarant of Trustee) desires to expand the scope of the Trust by adding a number of more object clauses to the existing main objects of the Trust by amending existing Trust Deed and for this purpose making this declaration.

NOW THIS DEED WITNESSETH and the Declarant hereby declares that he will hold the property described in the Schedule hereunder written (and not as the beneficial

owner) and other Trust Property mentioned above for the time being on the Trusts for carrying out the objects and subject to the provisions, terms and conditions hereinafter mentioned.

1. Name of the Trust :

The Trust will be known by the name of Amahra Educational Foundation Trust.

2. Area of Operation :

The Trust will be operating in whole of India as well as abroad.

3. Principal office of the Trust :

The principal office of the Trust will be situated at 303, Ali Enclave, Ashiana Road Raja Bazar, B.V. Collage, Patna, Bihar-800014. However, the Trustees may open branches or local offices at different places within the area of operation.

4. Main Objects of the Trust:

The main objects which the Trust will pursue to achieve are as follows:

a) To open, establish, acquire, run, and manage educational institutions of all kinds including universities, school and colleges, teacher training colleges, technical and professional institutions, etc.;

b) To grant and/or award scholarship, aid, fellowship to five meritorious and / or poor students, research scholars, fellows, etc. to provide support and aid for their further education every year;

c) To grant and/or award title and / or fellowship for outstanding work done by one person each in the field of education, medical science, art & culture, literature, social work and public life every year.

d) To establish, acquire, run, maintain, support and give grant, aid and to render other financial assistance to maternity homes, hospitals,

dispensaries, medical colleges, Para-medical colleges, nursing colleges, Yoga centers, Meditation center and other health care centers and to carry out medical research, by engaging in the research and development of all field of medical sciences, and in all therapies of medical treatment, so as to afford medical relief in a better way.

- e) To engage in or undertake or carry on all types of activities for well being of the poor and to ameliorate their sufferings in any manner and to alleviate the poverty.
- f) To engage in or undertake or carry on all types of charitable activities involving general public utility.
- g) To do or undertake any activity or work ancillary or incidental to the objects stated herein above.
- h) To run Education center free of cost for the poor and slum children.
- i) To organize medical camps for the poor and needy.
- j) To open women welfare center.
- k) To organize seminars, debates and dialogue, culturalevents.

PROVIDED that the income and property of the Trust howsoever derived shall be applied solely in and towards the objects of the Trust as set forth above, and the same shall be deemed to be held in trust on the obligation that they be exclusively so utilized and for no other purpose.

AND no part of the income or property aforesaid shall be paid, used, applied for the benefit of the SETTLOR or TRUSTEES or to any one or more of them, provided that this shall not prevent payment in good faith of remuneration to any person for service rendered and lawful expenses incurred by them on behalf of the trust.

37. Registration with authority: The Settlor shall take steps immediately after the execution of these presents to register this Trust with authority appointed by any act, governing public charities.

38. Transfer of Trust Fund: If this Trust ceases to function by reason of there being no trustees existing or the Trustees not carrying the objects of the Trust, or for any other reason, then with the approval of any prescribed authority or a court of law and on the application of any person connected with or interested in this Trust, the Trust Fund of the Trust then existing shall be transferred to any public Trust existing and functioning as such authority or court may think fit.
